A Message from the Associate Pastor



Friends,

What a difference a year makes. So many things have changed in the span of the last 12 months. We have brought on new staff in our Youth Ministry, and are excited to see how God will use Dave Garvey to partner with parents as they disciple their children. We have watched God use the faithful work of our Children's Ministry to enfold and love a growing number of children and young families into our church. We hired an upstart new Associate Pastor (God, help us all!). We banded together, in partnership with other Presbyterian churches to build a home through Habitat for Humanity. We have welcomed new faces into membership and baptized new people into our community. It has been a great year. And I give thanks to God for it.

But it has also been difficult. In February, our church experienced a great loss when our beloved pastor, Rev. Scott Hauser, was taken home to eternity. It wasn't the only loss we experienced this year – just a brief look at the necrology report will tell you that – but its impact upon our community was unparalleled. We continue to deal with the ripple effects of this loss. The office across the hall from where I sit writing this letter is dark and quiet... and that still hurts.

But, even as I reflect on the deep grief and difficult work of the last six months, and even as I consider the deep grief and difficult work of the next six, I can see God's hand at work. The loss of such an important part of our community could have torn us apart. For those who don't know us, it may have even been expected. But, I have been here for eleven years now, so I wasn't surprised to see us band together to take care of and love each other.

In this very letter last year, Scott wrote these words about you all:

At the heart of Crossroads are people who love Jesus and love one another; a community of disciples committed to sharing God's love here and now, but always with a prophetic eye toward God's call for the future.

That's what I have seen in the difficulties of the last year. I've seen people who love Jesus and who love one another. I've seen people who take community seriously, and their discipleship seriously. I have seen people committed to loving one another. And I have seen people who, even as they grieve, are looking forward to what God will do next. And I am excited to be a part of it.

The report in the pages that follow is but a glimpse of the many ways God has been at work in and through us this last year. But, there is only so much that words, and numbers and pictures can convey. The greatest report of the ministry of Crossroads is written on your hearts, because the greatest measure of the ministry of the Church is not found in numbers or words or pictures, but in transformed hearts and lives.

It has been a joy-filled and tear-filled year at Crossroads, and my guess is there are both joy and tears in our future. The God who has walked faithfully with us throughout this last year is not yet done. God is leading us into a future that God has prepared for us.

I look forward with anticipation to the work God will do in and through us, and I am grateful beyond words for the privilege of being your pastor.

And it is the seeds of that love that I believe will serve us well moving forward. We don't know what lies ahead. We don't know who we will call next or what the Holy Spirit has in mind. But we can be confident that if we accept the role of being good stewards of the seeds Scott planted and trust in the work of the Holy Spirit, we will continue to thrive as new and exciting ways to glorify God are revealed.

What is the Joseph Fund?

The Joseph Fund is a separate account designated to provide funds for expenditures required to maintain our buildings and grounds. In the old Testament, Joseph was a man of vision. One vision God gave him was to prepare for the future. Thus, using Genesis 41:29–41 as a basis for the name, the Joseph Fund was set up to begin gathering resources, just as Joseph did, in order to use them as the needs arose in the future. Donations by members of our Congregation provides the replenishment of our "stored" funds.

Why do we need a separate Fund?

Prior to 2009, these costs were funded by the Operating Budget which at times was problematic. As our buildings and grounds age, these costs have become more significant over time. Having a separate fund enables our Congregation to give specifically to the fund's stated purpose. Support from the Joseph Fund lessens the financial burden and unpredictability on the Annual Operating Budget. Without support of the Joseph Fund, the Annual Operating Fund could be faced with having to cut important funding elsewhere in its budget to offset these expenses. The fund received a restricted donation of \$30,000 in fiscal year 2016 that was used this fiscal year to update the Fireside Room. Still more funding is needed due to the upcoming physical plan replacement needs.

The Fund is in much need of new contributions. Please consider donating to the Joseph Fund as part of your regular giving.

Investing In Crossroads' Future (IICF) Fund

What is the Investing in Crossroads Future (IICF) Fund?

During our time of transition between permanent lead pastors, we were faced with a loss of membership and contributions which created significant budgetary challenges. To not be forced to drastically cut our ministries and staff to balance the budget, in 2013 an appeal was made to our Congregation and the Crossroads Foundation for extraordinary financial support. The IICF plan was to raise \$320,000 over two years equally from the Congregation and Foundation combined with \$160,000 of total Operating expense reductions. Our members responded by pledging \$617,478 and the Foundation committed \$160,000 for a total of \$777,478. Because of the increased contribution amount and the much better financial performance than budget as reported, the time horizon of support from IICF to the Operating Fund lengthened. Based on our cash position, remaining funds to be received and our 2018 budget, it is forecasted that the IICF will have enough funds to balance the Operating Budget this year, provided that our pledges meet or exceed budget.

Why Do We Need a Separate Fund?

The intent was to provide separate "bridge" funds to enable us to fund our operating deficits during our time of transition including the period with our new pastor as we grow our church again. The IICF donations were set aside in a separate fund so that money required to balance the operating budget could be transferred as needed. The IICF balancing funds are accounted as Other Income so that the structural operating deficit, pre-IICF support, is clearly visible.
