Please be advised that the insurance carrier for Crossroads does not cover any physical damage to volunteers' own vehicles being used for church activities; volunteers are personally responsible, individually or through your own insurance carrier, for any such damage their vehicles. Our insurance carrier strongly recommends the following minimum level of coverage for transporting people for ministry activities: Liability limits of \$100,000 per person/\$300,000 per accident, and Uninsured/Underinsured Motorist Coverage of the same (\$100,000 per person/\$300,000 per accident).

Examples of Minor Traffic Violations:

- Altered license or unlawful use of license or permit.
- Any passing violation.
- Driving on the wrong side of the road or in the wrong direction.
- Failure to yield to emergency vehicles.
- Failure to yield at intersection, stop sign, or traffic device.
- Moving violation resulting in filing of evidence of financial responsibility.
- School bus or school zone violation.
- Speed equal to or less than 15 mph over the limit

Examples of Major Traffic Violations:

- Careless/reckless driving.
- Drag racing or participation in speed contests.
- Speed in excess of 20 mph over the limit.
- Driver's license suspended, revoked, canceled, or barred.
- Driving while intoxicated or under the influence of drugs.
- Failure to stop and report accident involvement.
- Violation of Open Container Law.
- Possession of alcohol or drugs.
- Carrying a concealed weapon.
- Felony use of a motor vehicle.
- Homicide/assault while operating a vehicle.
- Manslaughter or vehicular homicide.
- Motor vehicle theft.
